#### 1.0 AMERICAS

#### 1.1 BACKGROUND

Americas, the two continents, North and South Americas, of the Western Hemisphere. The climatic zones of the two continents are quite different. In North Americas, subarctic climate prevails in the north, gradually warming southward and finally becoming tropical near the southern isthmus. In South Americas, the climate in the north is tropical, becoming cooler southward.

North Americas consists of 23 countries, including the United States, Canada, Mexico, and Central American nations like Guatemala and Panama. It also encompasses Caribbean nations like Cuba and Jamaica.

South Americas has 12 sovereign countries, including Brazil, Argentina, Colombia, and Peru, as well as territories like French Guiana and the Falkland Islands.

Christianity dominates both continents, largely due to European colonization.

Roman Catholicism is the majority faith, particularly in Latin Americas (Mexico, Central Americas, South Americas).

Protestantism is significant in the United States, Canada, and parts of the Caribbean. Indigenous spiritual traditions persist in smaller communities, especially in South Americas' Andean and Amazonian regions.

#### **North Americas:**

The United States is the largest economy, contributing over **\$25 trillion** to the region's GDP, followed by Canada and Mexico. The region is industrialized and leads in technology, manufacturing, and finance (ref, world bank data catalogue)

**Central Americas:** The Caribbean have smaller economies, focused on agriculture, tourism, and remittances.

#### **South Americas:**

Brazil is the largest economy (over **\$2.1 trillion**) and a key player in agriculture, mining, and energy.

Other significant economies include Argentina, Chile, and Colombia.

The continent depends heavily on natural resources, such as oil, minerals, and agricultural exports, but faces challenges like inequality and inflation.

- Americas' total imports were valued at USD 5157.2 Billion in 2023 and have an average growth rate of 6.9% per year between 2019 and 2023. Between 2022 and 2023, imports decreased by 5.8% from USD 5473.9 Billion in 2022 to USD 5157.2 Billion in 2023.
- Lead source markets in 2023 included: China (USD 794.3 billion; 15.4%), USA (USD 708.6 billion; 13.7%), Mexico (USD 559.7 billion; 10.9%), Canada (USD 459.2 billion; 8.9%) and Germany (USD 231.1 billion; 4.5%).

Americas' top import products in 2023 included: Motor cars and other motor vehicles (USD 292.5 billion), petroleum oils and oils obtained from bituminous minerals, crude (USD 208.1 billion), petroleum oils and oils obtained from bituminous minerals (Excl. crude) (USD 193.4 billion), Telephone sets (USD 168.0 billion), and Parts and accessories for tractors (USD 155.8 billion).

- Lead destination markets for Americas included: USA (USD 1045.1 billion; 26.2%), Canada (USD 384.7 billion; 9.7%), China (USD 364.9 billion; 9.2%), Mexico (USD 347.2 billion; 8.7%) and Netherlands (USD 116.4 billion; 2.9%). Collectively, the top 5 countries accounted for 56.7% of Americas' total exports in 2023.



 Top export products in 2023 were: Petroleum oils and oils obtained from bituminous minerals, crude (USD 166.4 billion), Petroleum oils and oils obtained from bituminous minerals (Excl. crude) (USD 124.7 billion), Motor cars and other motor vehicles (USD 113.5 billion), Parts and accessories for tractors (USD 92.3 billion) and Motor vehicles for transport of goods (USD 70.3 billion).

#### 4.1 Trade Balance

- The balance of trade in the reviewed period has been fluctuating throughout the decade. A positive balance of trade has been recorded with the peak value being USD 110.9 billion in 2014 and the lowest value being USD 89.2 billion in 2020.
- Intra Americas exports since 2014 has been fluctuating all through the decade long, but still growth has been realised from USD 1785.8 billion in 2014 to USD 2195.5 billion in 2023. The lowest value being USD 1466.4 billion in 2020. Best performing year was 2022 with exports reaching USD 2242.6 billion.
- Intra Americas imports have been fluctuating over the last 10 years. The
  peak import value was USD 2088.6 billion in 2023. Intra Americas imports
  have not been under USD 1401.8 billion throughout the decade.

• The value of Kenya's exports to Americas stood at USD 494.7 million in 2023 and has been increasing on an average rate of 0.2%\_ per year between 2019 and 2023.

• Kenya's principal export product to Americas in 2023 was Men's or boy's suits (20.1%). Other key export products include Coffee (12.8%), Jerseys, pullovers, cardigans (8.2%), Women's or girls' suits (7.6%) and Petroleum oils and oils obtained from bituminous minerals (6.6%)


• Kenya's imports from Americas were valued at USD 1242.3 million in 2023.

Kenya's leading and main import products from Americas in 2023 included: Petroleum gas and other gaseous hydrocarbons (USD 185.8 million), Cane or beet sugar and chemically pure sucrose in solid form (USD 148.5 million), Wheat and meslin (USD 90.8 million), Powered aircraft (USD 72.4 million) and Medicaments (USD 46.2 million).


